RESOLUTION NO. 9

RESOLUTION OF THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF HOCHATOWN, MCCURTAIN COUNTY, STATE OF OKLAHOMA, NOTIFYING THE PUBLIC OF THE PUBLICATION OF THE TOWN OF HOCHATOWN CODE OF 2023; DIRECTING THE TOWN CLERK TO FILE A COPY OF THIS RESOLUTION WITH THE MCCURTAIN COUNTY CLERK; DIRECTING THE TOWN CLERK TO FILE A COPY OF THIS RESOLUTION AND THE CODE WITH THE MCCURTAIN COUNTY LAW LIBRARY; DIRECTING THE TOWN CLERK TO KEEP AT LEAST THREE (3) COPIES OF THE CODE IN THE OFFICE OF THE TOWN CLERK FOR PUBLIC USE, INSPECTION AND EXAMINATION.

WHEREAS, the Town of Hochatown has compiled and published its Ordinances to prepare the Town of Hochatown Code of 2023; and

WHEREAS, the Town is required to publish its code of compiled penal ordinances and to deposit a copy with the county law library pursuant to Sections 14-109 and 14-110 of Title 11 of the Oklahoma Statutes; and

WHEREAS, the Town is required to adopt a resolution notifying the public of the publication of its code pursuant to Section 14-110 of Title 11 of the Oklahoma Statutes and to file a copy of the resolution in the office of the County Clerk;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF HOCHATOWN, MCCURTAIN COUNTY, STATE OF OKLAHOMA:

THAT the Town Clerk shall cause to be filed one (1) copy of this Resolution with the office of the County Clerk of McCurtain County; and

THAT the Town Clerk shall cause one (1) copy of this Resolution and one copy of the Code to be filed with the Law Library of McCurtain County; and

THAT the Town Clerk shall keep at least three (3) copies of the Hochatown Code of Ordinances of 2023 in the office of the Town Clerk for public use, inspection and examination.
