## **RESOLUTION NO. 2025-15**

## A RESOLUTION OF THE TOWN OF HOCHATOWN, OKLAHOMA, ESTABLISHING REGULAR MUNICIPAL COURT DATES AND TIMES

WHEREAS, the Town of Hochatown ("Town") has established a municipal court pursuant to applicable Oklahoma law to adjudicate violations of Town ordinances; and WHEREAS, it is necessary and proper for the Board of Trustees to fix regular court dates and times for the orderly and efficient administration of justice; and WHEREAS, the Town intends to commence regular court sessions in December 2025 and thereafter maintain a predictable, recurring schedule.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Hochatown, Oklahoma:

- 1. **Initial December 2025 Court Dates.** The Town hereby sets the following municipal court dates to commence regular court operations:
  - o Monday, December 8, 2025, at 10:00 a.m.
  - o Monday, December 22, 2025, at 10:00 a.m.
- 2. Regular Recurring Schedule (Beginning January 2026). Starting in January 2026 and continuing thereafter until modified by the Board, municipal court shall convene on the second (2nd) and fourth (4th) Monday of each month at 10:00 a.m.
- 3. Location. Unless otherwise noticed, all sessions shall be held at the Hochatown Town Hall or such other publicly noticed location designated by the Town.
- 4. Holidays/Closures and Continuances. If a scheduled court date falls on a Town-observed holiday, or if Town facilities are closed or unavailable, that session may be continued to the next available date by order of the Municipal Judge or rescheduled by the Town, with reasonable notice to parties.
- 5. Notice and Calendaring. The Town Clerk (or designee) shall publish the court calendar on the Town's official website and bulletin board and provide notice of any changes consistent with law and court rules.
- 6. Severability. If any provision of this Resolution is held invalid, the remainder shall not be affected and shall continue in full force and effect.
- 7. Effective Date. This Resolution shall take effect immediately upon adoption.
